Pursuant to the New HR methodology for induction of Agniveervayu under 'Agnipath Scheme', aimed to provide an opportunity to Nation's youth to
experience military way of life for a period of four years, Indian Air Force invites ONLINE applications from unmarried Indian male and female
candidates for selection test from 22 March 2025 onwards to join the IAF as an AGNIVEERVAYU. The number and employability of female candidates will be decided as per service requirement.

(THE SELECTION TEST IS NOT FOR SELECTION AS COMMISSIONED OFFICERS/ PILOTS/ NAVIGATORS/ AIRMEN)

- Application is required to be filled only ONLINE by the candidates and detailed instructions to fill up the same are available a https://agnipathvayu.cdac.in
- This examination is valid for AGNIVEERVAYU INTAKE 01/2026.
- ONLINE REGISTRATION shall commence at 1100 Hr on 07 January 2025 and will close at 2300 Hr on 27 January 2025. Only ONLINE REGISTERED applications shall be accepted. For registration log on to https://lagnipathvayu.cdac.in.
 - Candidates are advised to register at the earliest opportunity as no extension of registration dates will be accommodated.

ELIGIBILITY CRITERIA

- 5. <u>Age</u>
 - (a) Date of Birth Block. Candidates born between 01 January 2005 and 01 July 2008 (both dates inclusive) are eligible to apply.
 - In case, a candidate clears all the stages of the Selection Procedure, then the upper age limit as on date of enrolment should be 21 years
- 6. Marital Status and Pregnancy. Only unmarried candidates (male & female) will be eligible for enrolment as Agniveervayu and they shall undertake not to many during the defined engagement period of four years. Keeping in view limited period of engagement of Agniveervayu inclusive of training, skill development activities, practical as well as formative assessment and organisational requirement of continued service of Agniveervayu during the engagement period will adversely affect the operational efficiency of the Indian Air Force. Agniveervayu who marry during the said period shall be discharged from the service. Further, only unmarried Agniveervayu will be eligible for Selection in regular cadre as Airman. Female candidates additionally shall be required to undertake not to get pregnant during the engagement period of four years. Such women Agniveervayu on becoming Low Medical Category (LMC) due to pregnancy shall liable to be discharged from service. Pregnancy will obear the women Agniveervayu for selection into Regular Cadre. At the time of enrolment, candidates shall require to sign a voluntary undertaking accepting above conditions. conditions
- 7. Educational Qualification
 - Science Subjects

Candidates should have passed Intermediate/ 10+2/ Equivalent examination with Mathematics, Physics and English from Education Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

OR

Passed Three years Diploma Course in Engineering (Mechanical/ Electrical/ Electronics/ Automobile/ Computer Science/ Instrumentation Technology / Information Technology) from Central, State and UT recognized Polytechnic institute with 50% marks in aggregate and 50% marks in English in Diploma Course (or in Intermediate/Matriculation, if English is not a subject in Diploma Course).

Passed Two years Vocational Course with non-vocational subject viz. Physics and Mathematics from Education Boards recognized by central, State and UT with 50% marks in aggregate and 50% marks in English in Vocational Course (or in Intermediate / Matriculation, if English is not a subject in Vocational Course).

Other than Science Subjects

Passed Intermediate / 10+2 / Equivalent Examination in any stream/subjects from Education Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

Passed two years Vocational Course from Education Boards recognized by Central, State and UT with minimum 50% marks in aggregate and 50 marks in English in Vocational Course (or in Intermediate / Matriculation if English is not a subject in Vocational Course).

- 8. <u>Domicile Category.</u> Candidates have to choose one of the domicile categories mentioned below and declare the same as their domicile state/ UT in the domicile column in the orline application form at the time of online registration. They are also required to upload the relevant Domicile Certificate/ COAFP Certificate as per the category chosen. The following are the categories of domicile:
 - Permanent Domicile. Permanent Domicile of the districts of State(s)/ UTs. The candidate shall produce 'Domicile Certificate' issued by any d Officer in Revenue Department or any other official authorized by the State Government of the particular State/ UT.
 - Children of serving Air Force personnel [Officers/ Airmen/ NCs(E) and Unit cadre Civilians paid from Defence Estimates] COAFP whose father/ mother is presently serving in any Air Force Unit/ any other Organisation located in the districts of State(s)/ UTs. Such candidates will produce latest COAFP (Children of Air Force Personnel) Certificate.
 - (c) <u>COAFP</u>. Children of Air Force personnel [Officers/ Airmen/ NCs(E) and Unit Cadre Civilians paid from Defence Estimates] whose father/ mother is Retired/ Discharged/ Deceased and they are residing in the districts of State(s)/ UTs. Such candidates will produce a proof of minimum stay of one year along with original and photocopy of Service Book/Discharge Book/ Casualty Service Certificate/ Certificate (issued from DPO-3/ DAV as applicable) in case of Officers/ Airmen/ NCs(E) and a Certificate duly signed by OIC Civil Admin and counter signed by CO/ C Adm O of the last served unit, in case of Civilians.

Note. Domicile Category once chosen will not be changed later as the same will be applicable to the candidate at the time of shordlisting for Phase-II exam and preparation of Provisional Select List (PSL) which will be done state-wise as per the vacancies allocated for each state UT. As per the category chosen during registration, candidate will be required to produce relevant original Domicile Certificate/COAFP Certificate (if shortlisted for Phase-II Exam) for every stage of selection till enrolment.

- General Medical Standards for AGNIVEERVAYU male & female candidates are as follows :-Mandatory Medical Standards.
 - Height.
 - (i) For Male candidates. Minimum acceptable height is 152 cms.
 - For Female candidates. Minimum acceptable height is 152 cms. For candidates belonging to North East or hilly regions Uttarakhand, a lower minimum height of 147 cms will be accepted. In case of candidates from Lakshadweep, the minimum height will be 150 cms.

Note. Candidates availing height relaxation for being domicile of North East/ Hilly Regions of Uttarakhand/ Lakshadweep are to submit domicile certificate with endorsement of domicile status at the time of Phase-Il testing, Further, candidates from hilly regions of Uttarakhand must have specific endorsement of hilly region in their domicile certificate.

- Weight. Weight should be proportionate to height and age as applicable for IAF
- (c) Chest.
 - For Male candidates. The chest wall should be well proportioned and well developed. Minimum chest ference should be 77 cms and the chest expansion should be atleast 05 cms.
 - For Female candidates. The chest wall should be well proportioned and should be with minimum range of
- Hearing. Candidate should have normal hearing i.e. able to hear forced whisper from a distance of 6 meters by each , ır separat
- Should have healthy gums, good set of teeth and minimum 14 dental points
- (f) <u>General Health.</u> Candidate should be fit for the Air Force, must conform to the medical standards and should be of normal anatomy without loss or deformity of any appendages. He / She should be free from any active or latent, acute or chronic, perform duty in any part of the world, in any climate and terrain.
- Gynaecological Examination (For female candidates). The examination covers external genitalia, hernia orifices and the , any evidence of stress urinary incontinence or genital prolapse outside introllus.
- Gender. Any candidate if found to have predominant characteristics of the opposite gender as evident on externa physical examination, will be rejected as Unfit. Any candidate having undergone gender reassignment surgery will be declared Unfit.
- Pregnancy (For female candidates). Any candidate, if found pregnant shall be disqualified and her candidature will be
- (k) <u>Body Tattoo.</u> Permanent body tattoos are not permitted. However, tattoos only on inner face of the fore arms (inside of elbow to the wrist), back (dorsal) part of the hand/reverse side of palm and Tribals with tattoos which are as per custom and traditions of their tribes may be considered. Offensive, obscene, indecent, sexist or racist tattoos are prohibited regardless of location on the Body. However, right to consider a tattoo acceptable or unacceptable will rest with the Selection Centre. Date of prescription should be within a month prior to appearing for medical examination.

- 10. <u>Consumption of Narcotic Drugs and Psychotropic Substance (NDPS)</u>. TERMS AND CONDITIONS

- 12. Agniveervayu will be enrolled in the Indian Air Force under Air Force Act 1950, for a period of **FOUR years**. Agniveervayu would form a distinct rank in the Indian Air Force, different from any other existing ranks. The Indian Air Force is not obliged to retain Agniveervayu beyond the engagement period of four years.
- 13. On completion of four years of service, based on organisation's requirements and policies promulgated by the Indian Air Force, Agniveervayu will be offered an opportunity to apply for enrolment in the regular cadre of the Indian Air Force as Airmen. These applications will For interval will be underso in opportunity to epily of inclination in the signal cause of the industrial role as animals. Interest application to be considered in a centralised manner based on objective criteria, including performance during their four-year engagement period and up to 25% of each specific batch of Agniveervayu will be enrolled in regular cadre of IAF. Agniveervayu will not have any right to be selected for further enrollment into the Indian Air Force. Selection of the Agniveervayu for further enrollment, if any, shall be at the discretion of the Government of India.
- 14. <u>Employability</u>. Agniveervayu enrolled under this entry are liable to be assigned any duty in organisational interest at the discretion of the Indian Air Force.
- 15. Training. On being enrolled, Agniveervayu will be imparted military training based on Indian Air Force requirements.
- Leave. Grant of leave will be subject to exigencies of the Indian Air Force. The following leave is applicable for Agniveervayu during their
 - (a) Annual Leave. 30 days per year.
 - Sick Leave. Based on medical advice by competent Medical Authority.
- Medical and CSD Facilities. For the duration of their engagement period in the Indian Air Force, Agniveervayu will be entitled for adical facility at Service Hospitals as well as CSD provisions.
- 18. Pav. Allowances and Allied Benefits. Agniveervayu enrolled under this Scheme will be paid an Agniveer package of ₹30,000/- per month with a lixed yearly incernent. In addition, Risk and Hardship allowances (as applicable in IAF), Dress and Travel allowances will be paid. Perks such as radion, clothing, accommodation and Leave Travel Concession (LTC), shall also be provided as per the existing rules.
- Terminal Benefits Seva Nidhi Package. AGNIVEERVAYU will be given one time 'Seva Nidhi' package comprising of their monthly ntribution along with matching contribution by the Government on completion of their engagement period, as indicated below.

- Note 2.. There shall be no entitlement to gratuity and any kind of pensionary benefits.
- 20. Insurance, Death and Disability Compensation. AGNIVEERVAYU will be provided non-contributory Life Insurance cover of ₹ 48 Lakhs for the duration of their engagement period as AGNIVEERVAYU in the Indian Air Force. AGNIVEERVAYU will not be governed by provisions contained in the Pension Regulations/ Rules for Indian Air Force. For details of Death/ Disability compensation log on to https://agnipathvayu.cdac.in.
- Agniveer Skill Certificate. At the end of engagement period, a detailed Skill-Set certificate will be provided to the AGNIVEERVAYU, highlighting the skills and level of competency acquired by the personnel during their engagement period.
- Not Entitled to the ESM Status. Agniveervayu enrolled under this Scheme will not be eligible for Ex-Servicemen status after their discharge from rvice on completion of four years engagement period.
- Agniveervayu will not be permitted to appear in any examination for commissioning in ArmylNavylIAF during the engagement period of four yeunless he/she has applied for said exam before getting enrolled.
- 24. Release at own request prior to completion of engagement period will not be permissible for Agniveervayu, However, in exceptional cases, personnel enrolled as Agniveervayu may be released, with approval of the Competent Authority.

 - (a) Science Subjects. Total duration of the online test shall be <u>60 minutes</u> and shall comprise of **Physics**, **Mathematics and English** as per 10+2 CBSE syllabus.
 - Other than Science Subjects. Total duration of the online test shall be 45 minutes and shall comprise of English as per 10+2 CBSE d Reasoning & General Awareness (RAGA). syllabus and Reas
 - (c) Science Subjects & Other than Science Subjects. Total duration of the online test shall be <u>85 minutes</u> and shall comprise of Physics, Mathematics and English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RAGA).
 - Marking pattern for online test: (d)
 - (i) One mark for every correct answer.
 - (ii) Nil (0) marks for unattempted question.
 - (iii) 0.25 marks shall be deducted for each wrong answer.

- 26. Marks scored by the candidates in STAR Phase-I Testing will be "Normalised" by using the formula as published on the web site https://annipathyavu.cdac.in, to take into account variation in difficulty levels of the question papers across different sessions. Candidates are to note that the application of Cut-Off for shortlisting of candidates for STAR Phase-I testing and preparation of Final Merit List for selection will be based on "Normalised Marks" and not on the "Actual Marks" scored by the candidate in STAR Phase-I testing, Further, on normalisation, marks scored by a candidate in a subject. may become less/more than actual marks, and more than total marks of that subject in exceptional cases. Shortlisting for Phase-II testing will be carried out in state-wise manner. The Cut-Off marks for shortlisting for Phase-II testing may vary from state to state as vacancies have been allocated in a state-wise manner.
- 27. CANDIDATES ARE TO QUALIFY IN EACH PAPER INDMIDUALLY IN SCIENCE SUBJECTS AND OTHER THAN SCIENCE SUBJECTS, with normalised marks. - Candidates discharged from the IAF for any reason are not eligible to appear in the selection test.

- Additional Skills/ Qualifications/ Achievements. - 30. <u>Verification of Eliqibility.</u> Candidates should be in possession of the documents mentioned at para 28 & 29 above, when appearing for the Jselection test which would be scrutinised verifieed prior to commencement of Phase-II to ascertain the eligibility prima-facie. Detailed verification of all the documents isleted at para 28 & 29 above shall be carried out in respect of candidates who pass Physical Fitness Test.  - In the case of COAFP, the name of the candidate, parent's name and the date of birth of the candidate as mentioned in the discharge rvice book/ service particular certificate / casualty certificate (as applicable) must be the same as mentioned in the matriculation passing
 - Note-2. Under no circumstances, the candidates shall be permitted to appear in Phase-II of the selection test without original educational marks sheets/ passing certificates & documents mentioned above in paragraph 28.
